- Web beacons and pixel tags
- Browser fingerprint data
- Software and hardware configuration data
- The date and time the website and services were accessed
- Geographical location data
- Other types of personal information required for processing in accordance with the website conditions
- Personal information the Company receives from Global FT Market Partners in accordance with the terms and conditions
- of the agreements concluded by you and your Partner, as well as the agreements concluded by the Company
- and the Partner.

How we will use the information that we collect about you?

- Create and maintain your account;
- Allow you to log in to Global FT Market;
- Contact you about your account and/or the services that Global FT Market offers.
- Manage our marketing relationships. These include without limitation.
 - ❑ Learning about your interests and preferences to contact you with information that is relevant to you and helping us target marketing communications.
 - ❑ Using your pseudonymised details to show you advertising on social media platforms, such as Facebook or via other third party advertising that may appear on other websites you use. The information shared with these platforms is pseudonymised to protect your personal data.
